

**CONDITIONS OF COMPETITION - The following conditions shall be in effect for this competition:**

- GSGA competitions are "spikeless" events. Therefore, metal and traditionally-designed spikes are prohibited. Penalty for breach of this condition is disqualification.
- Players are responsible for posting their scores to the handicap system upon conclusion of this competition. Scores must be posted as tournament scores. Course slope and rating information is typically posted at the scoreboard during the competition. You may also contact GSGA for this information. Your scores are subject to review by your peers and your club's handicap committee.

<b>COMPETITION</b>	Four-Ball Championship
<b>ELIGIBILITY</b>	Open to two-man teams of male amateur golfers
<b>FIELD</b>	Low 80 entries by combined team USGA Handicap Index
<b>FORMAT</b>	54 holes of four-ball stroke play with cut to low 40 teams and ties after 36 holes.
<b>PRACTICE ROUNDS</b>	<p>One practice round per player. Practice rounds will be available on the designated times below prior to the competition. Please call <a href="#">Glen Arven Country Club</a> to reserve your practice round starting time <b>after April 5</b>. Practice round cart and range fee is \$25 plus tax. <u>Credit cards ONLY</u> will be accepted.</p> <ul style="list-style-type: none"> <li>• Wednesday-Thursday, anytime</li> <li>• Friday-Sunday after 1:00 p.m.</li> </ul>
<b>YARDAGES &amp; TEES</b>	The Championship (BLACK) tee markers and yardages will be utilized. Yardages are approximate and may be adjusted due to inclement weather or other factors that may affect the playing conditions during the competition.
<b>GOLF SHOP &amp; DRIVING RANGE:</b>	The golf shop and driving range will open at 7:00 a.m. each day of competition.
<b>STARTING TIMES</b>	Starting times for tournament play will be assigned by the GSGA and posted at the club the day before the competition starts. You may visit <a href="http://www.gsga.org">www.gsga.org</a> for complete pairing information and starting times beginning on April 15.
<b>REGISTRATION</b>	Formal registration will NOT be held on site. <b>Player/team withdraws must be called in or e-mailed in to the GSGA office so that an alternate team may be contacted.</b>
<b>CARTS</b>	Practice round cart and range fees are \$25 plus tax. <u>Credit cards ONLY will be accepted.</u> Tournament round cart and range fees are included in the entry fee.
