CONDITIONS OF COMPETITION - The following conditions shall be in effect for this competition:

- GSGA competitions are "spikeless" events. Therefore, metal and traditionally-designed spikes are prohibited. Penalty for breach of this condition is disqualification.
- Players are responsible for posting their scores to the handicap system upon conclusion of this competition. Scores must be posted as tournament scores. Course slope and rating information is typically posted at the scoreboard and on your scorecards during the competition. You may also contact GSGA for this information. Your scores are subject to review by your peers and your club's handicap committee.

COMPETITION	Four-Ball Tournament
ELIGIBILITY	Open to two-man teams of male amateur golfers who have a minimum combined team handicap index of 4.0 and a maximum handicap differential of six strokes.
FIELD	96 teams = 82 teams determined by lottery, three spots reserved for each host club and one spot reserved for each of the previous year's flight winners provided they are playing with the same partner.
FORMAT	54 holes of flighted, four-ball stroke play.
COURSE ASSIGNMENTS	The Championship division of 48 teams will compete on the Indian Mounds course and the Flighted division of 48 teams will compete on the Pine Lakes course at Jekyll Island Golf Club.
PRACTICE ROUNDS	 One practice round per player. Practice rounds will be available on the designated times below two weeks prior to the competition. Please contact <u>Jekyll Island Golf Club</u> to reserve your practice round starting time after March 20. Practice round cart and range fee is \$30 plus tax. Cash and credit cards will be accepted. Monday-Thursday, anytime
YARDAGES & TEES	Yardages will be posted online before the close of entries and at the host club. Yardages are approximate and may be adjusted due to inclement weather or other factors that may affect the playing conditions during the competition.
GOLF SHOP & DRIVING RANGE:	The golf shop and driving range will open at 7:00 a.m. each day of competition.
STARTING TIMES	Starting times for tournament play will be assigned by the GSGA and posted at the clubs the day before the competition starts. You may visit <u>www.gsga.org</u> for complete pairing information and starting times beginning on March 24.
REGISTRATION	Formal registration will not be held on site. Player/team withdraws must be called in or e-mailed to the GSGA office so that an alternate team may be contacted.

CARTS	Practice round cart and range fee is \$30 plus tax. Cash and credit cards will be accepted. Tournament round cart and range fees are included in the entry fee.
