

**CONDITIONS OF COMPETITION - The following conditions shall be in effect for this competition:**

- GSGA competitions are "spikeless" events. Therefore, metal and traditionally-designed spikes are prohibited. Penalty for breach of this condition is disqualification.
- Players are responsible for posting their scores to the handicap system upon conclusion of this competition. Scores must be posted as tournament scores. Course slope and rating information is typically posted at the scoreboard during the competition. You may also contact GSGA for this information. Your scores are subject to review by your peers and your club's handicap committee.

<b>COMPETITION</b>	Mid-Amateur Championship
<b>ELIGIBILITY</b>	Open to male amateur golfers age 25 or older as of May 20, 2016.
<b>FIELD</b>	144 players
<b>FORMAT</b>	54 holes of individual stroke play. After 36 holes of play, the field will be cut to the low 70 scores and ties.
<b>CHAMPIONSHIP FEE</b>	<i>Player's advancing to the Championship through qualifying will be responsible for a \$125.00 Championship fee. This fee will be charged to the player upon being transferred to the Championship proper in the online registration system after your qualifying round has concluded.</i>
<b>PRACTICE ROUNDS</b>	One practice round per player. Practice rounds will be available on the designated times below two weeks prior to the competition on a space available basis. Please contact <a href="#">Augusta Country Club</a> to arrange your practice round starting time. Practice round cart and range fee is \$25 plus tax. <b>Cash ONLY</b> will be accepted for payment. <ul style="list-style-type: none"> <li>• Tuesday-Thursday, anytime</li> </ul>
<b>YARDAGES &amp; TEES</b>	The CHAMPIONSHIP tee markers and yardages will be utilized for the qualifying round. Yardages are approximate and may be adjusted due to inclement weather or other factors that may affect the playing conditions during the competition.
<b>GOLF SHOP &amp; DRIVING RANGE:</b>	The golf shop and driving range will open at 6:30 a.m. on the day of qualifying.
<b>STARTING TIMES</b>	Starting times for tournament play will be assigned by the GSGA and posted at the clubs the day before the competition starts. You may visit <a href="http://www.gsga.org">www.gsga.org</a> for complete pairing information and starting times beginning on <b>May 13</b> .
<b>REGISTRATION</b>	NO formal registration will be held on site. Players should arrive to their assigned starting tee ten minutes before their starting time to allow for the starter to go over instructions and rules of play. Player withdrawals must be called in to the GSGA office or e-mailed to the Rules & Competitions Department.

<b>CARTS</b>	Practice round cart and range fee is \$25 plus tax. <b>Cash ONLY</b> will be accepted for payment. Tournament round cart and range fees are included in the entry fee.
<b>RULES OF PLAY/PACE OF PLAY/CART POLICY</b>	The GSGA Rules of Play, Pace of Play and Cart Policies shall be in effect. <a href="#">Click here to view the policies.</a>
<b>CADDIES</b>	Players may provide their own caddie.
