YARDAGES & TEES	The BLACK tee markers and yardages will be utilized for the qualifying round. Yardages are approximate and may be adjusted due to inclement weather or other factors that may affect the playing conditions during the competition.
GOLF SHOP & DRIVING RANGE:	The golf shop and driving range will open at 7:30 a.m. on the day of qualifying.
