  typically posted at the scoreboard and on scorecards during the competition. You may also contact

COMPETITION	Mid-Amateur Championship Qualifying – The Landings Club (Deer Creek)
ELIGIBILITY	Open to male amateur golfers age 25 or older as of May 19, 2017.
FIELD	100 players maximum at each qualifying site.
FORMAT	18 hole individual stroke play qualifier. A total of 144 players will advance to the Championship proper. Qualifying places will be awarded according to a prorated formula. You will be informed as to the number of qualifying places in your section the day of qualifying.
CHAMPIONSHIP FEE	Player's advancing to the Championship will be responsible for a \$125.00 Championship fee. This fee will be charged to the player upon being transferred to the Championship proper in the online registration system after your qualifying round has concluded.
PRACTICE ROUNDS	One practice round per player. Practice rounds will be available on the designated times below prior to the competition. YARDAGES & TEES	The CHAMPIONSHIP tee markers and yardages will be utilized for the qualifying round. Yardages are approximate and may be adjusted due to inclement weather or other factors that may affect the playing conditions during the competition.
GOLF SHOP & DRIVING RANGE:	The golf shop and driving range will open at 7:00 a.m. on the day of qualifying.

REGISTRATION	No formal registration will be held on site.
