

**CONDITIONS OF COMPETITION - The following conditions shall be in effect for this competition:**

- **GSGA competitions are "spikeless" events. Therefore, metal and traditionally-designed spikes are prohibited. Penalty for breach of this condition is disqualification.**
- **Players are responsible for posting their scores to the handicap system upon conclusion of this competition. Scores must be posted as tournament scores. Course slope and rating information is typically posted at the scoreboard during the competition. You may also contact GSGA for this information. Your scores are subject to review by your peers and your club's handicap committee.**

<b>COMPETITION</b>	Senior/Super Senior Match Play Championship
<b>ELIGIBILITY</b>	Open to male amateur golfers ages 55 or older for the Senior division and 65 or older for the Super Senior division as of April 12, 2016.
<b>FIELD</b>	Low 120 entries by USGA Handicap Index.
<b>FORMAT</b>	Match play preceded by 36-holes of stroke play qualifying. Low 16 players advance to match play in the Senior division; Low 8 players advance to match play in the Super Senior division (subject to change based on number of entries).
<b>PRACTICE ROUNDS</b>	<p>One practice round per player. Practice rounds will be available on the designated times below two weeks prior to the competition. Please call <a href="#">Horseshoe Bend Country Club</a> to reserve your practice round starting time. Practice round cart and range fee is \$22 plus tax. <b>YARDAGES &amp; TEES</b>	The BLUE tee markers and yardages for the Senior division and the WHITE tee markers and yardages will be utilized for the Super Senior division of the Championship. A practice yardage sheet will be made available for practice rounds. Yardages are approximate and may be adjusted due to inclement weather or other factors that may affect the playing conditions during the competition.
<b>GOLF SHOP &amp; DRIVING RANGE:</b>	The golf shop and driving range will open at 7:00 a.m. each day of competition.
<b>STARTING TIMES</b>	Starting times for tournament play will be assigned by the GSGA and will be posted at the club the day before the competition starts. You may visit <a href="http://www.gsga.org">www.gsga.org</a> for complete pairing information and starting times beginning on April 5.
<b>REGISTRATION</b>	No formal registration will be held on site. <b>Player withdraws must be called in or e-mailed to the GSGA office so that an alternate may be contacted.</b>

<b>CARTS</b>	Practice cart and range fees are \$22 plus tax. Credit cards <u>ONLY</u> will be accepted. Tournament round cart and range fees are included in the entry fee.
