

CONDITIONS OF COMPETITION - The following conditions shall be in effect for this competition:

- GSGA competitions are "spikeless" events. Therefore, metal and traditionally-designed spikes are prohibited. Penalty for breach of this condition is disqualification.
- Players are responsible for posting their scores to the handicap system upon conclusion of this competition. Scores must be posted as tournament scores. Course slope and rating information is typically posted at the scoreboard during the competition. You may also contact GSGA for this information. Your scores are subject to review by your peers and your club's handicap committee.

COMPETITION	Super Senior Championship
ELIGIBILITY	Open to male amateur golfers age 65 or older as of August 1, 2016
FIELD	Low 36 entries by USGA Handicap Index will comprise the Championship flight and remaining 108 players will be determined by lottery.
FORMAT	36 holes of flighted stroke play
PRACTICE ROUNDS	<p>One practice round per player. Practice rounds will be available on the designated times below two weeks prior to the competition. Please Heron Bay Golf Club to reserve your practice round starting time. Practice round cart and range fee is \$25 plus tax. Cash and credit cards will be accepted for practice rounds.</p> <ul style="list-style-type: none"> • Tuesday-Thursday, anytime based on availability. • Friday-Sunday, after 1:00 p.m. based on availability.
YARDAGES & TEES	A combination of tee markers (primarily TBA) will be utilized for the championship. Yardages are approximate and may be adjusted due to inclement weather or other factors that may affect the playing conditions during the competition. A detailed yardage sheet will be provided when playing practice rounds.
GOLF SHOP & DRIVING RANGE:	The golf shop and driving range will open by 7:00 a.m. each day of competition.
STARTING TIMES	Starting times for tournament play will be assigned by the GSGA and posted at the club the day before the competition starts. You may visit www.gsga.org for complete pairing information and starting times beginning on July 25.
REGISTRATION	No formal registration will be held on site. Player withdraws must be called in or e-mailed to the GSGA office so that an alternate may be contacted.
CARTS	Practice round cart and range fees are \$25 plus tax. Cash and credit cards will be accepted. Tournament round cart and range fees are included in the entry fee.
