CONDITIONS OF COMPETITION - The following conditions shall be in effect for this competition:

- USGA competitions are "spikeless" events. Therefore, metal and traditionally-designed spikes are prohibited. Penalty for breach of this condition is disqualification.
- The player's clubs must conform to the groove specifications in *The Rules of Golf* that are effective from January 1, 2010.

PENALTY FOR CARRYING, BUT NOT MAKING STROKE WITH, CLUB OR CLUBS IN BREACH OF CONDITION: Two strokes for each hole at which any breach occurred; maximum penalty per round – Four strokes. In the event of a breach between the play of two holes, the penalty applies to the next hole.

Any club or clubs carried in breach of this condition must be declared out of play by the player to her marker or fellow-competitor immediately upon discovery that a breach has occurred. If the player fails to do so, he is disqualified.

PENALTY FOR MAKING STROKE WITH CLUB IN BREACH OF CONDITION: Disqualification.

Amateur players are responsible for posting their scores to the handicap system upon conclusion of this
competition. Scores must be posted as tournament scores. Course slope and rating information is
typically posted at the scoreboard during the competition. You may also contact GSGA for this
information. Your scores are subject to review by your peers and your club's handicap committee.

Practice round cart and range fee is \$25 plus tax and must be paid regardless of whether or not the player chooses to walk or ride. CASH ONLY will be the accepted method of payment in the golf shop. • Contact the pro shop for practice round availability at (770) 640-4625.
CARTS	Practice cart and range fees are \$25 plus tax. CASH ONLY will be accepted. During the qualifying round, a caddie may transport a player's bag on a cart for a fee of \$25 plus tax. Spectator carts are strictly prohibited in all instances.

REGISTRATION	NO formal registration will be held on site. Players should arrive to their assigned starting tee ten minutes before their starting time to allow for the starter to go over instructions and rules of play. CADDIES	Players may provide their own caddie.
RULES OF PLAY/PACE OF PLAY/CART POLICY	The USGA Rules of Play and GSGA Pace of Play Policies shall be in effect. Click here to view policies.
PREFERRED LIES	Per the USGA, for all USGA Championships and qualifying rounds, the following policy is in effect: A Local Rule authorizing "Preferred Lies" or "Winter Rules" is NEVER permitted.
PERSONAL APPEARANCE	In Local and Sectional Qualifying stages and the Championship proper, players must be neat in appearance with respect to clothing and personal grooming. The Committee in charge decides whether this requirement has been met, and has the authority to withdraw the entry of a player who does not comply. The wearing of short pants is prohibited in the Championship proper, but is permissible in Local and Sectional Qualifying provided the host club does not have a dress code prohibiting such.
FOOD & BEVERAGE SERVICE	Food service will be available at the club throughout the day. CASH ONLY will be accepted for F & B purchases.
